HGSE Courses

Summer courses offered during academic year 2022-2023 are viewable in <u>My.Harvard</u>. Please be aware that development of the full academic year 2022-23 course list is still in progress and scheduled to be released on July 15. You can only search for your Summer 2022 courses. The "Course Search" tab is where you will select your courses and add them to your Crimson Cart and subsequently enroll in them.

My. Harvard Check-In

Check-in in My.Harvard will begin on Tuesday, May 3rd (at 12:01 a.m. ET). You will be able to complete the check-in process by following these steps. The deadline to check-in within My.Harvard is Tuesday, June 21 by 11:59 p.m. ET. All students are required to check-in for the summer semester. When you have completed the Check-in process, you will be able to move forward to enroll in classes.

Title IX Training

As a community, it is our shared responsibility to prevent sexual assault on our campus and to create a culture where sexual and gender-based violence and harassment of any kind is unacceptable.

To help address the serious and pervasive problem of sexual harassment and assault, Harvard has developed an online training module entitled "Preventing and Responding to Sexual Harassment and Other Sexual

<u>Misconduct (2022-23)</u>" This module was developed with input from students and is designed to educate members of our community about:

- 1. The resources that exist at the University for the prevention of and response to incidents of sexual and gender-based harassment, including sexual assault; and,
- 2. The Sexual and Gender-Based Harassment Policy for Harvard University.

This training module is mandatory for all HGSE students, both incoming and returning. In order to complete the module, please follow <u>this link</u>. Please note: **the module must be completed before registering for classes** (**including How People Learn (HPL))**—a hold will be placed on your registration until you have done so.

Please plan to complete the training and the assessment on a PC or laptop computer. To complete the module, you will need to disable your computer's pop-up blocker. If you have any technical issues, questions, or concerns about the training, please contact Title IX Resource Coordinator Kevin Boehm (kevin boehm@gse.harvard.edu). We also encourage you to share your feedback on the module, which will help inform future changes and additions, via the email address above.

If you encounter any problems launching the course, please follow this step-by- step guide to troubleshoot common issues.

- 1. The course requires a web browser that supports HTML5: Google Chrome, Firefox, Safari, Edge, or Internet Explorer.
- 2. Make sure that any pop-up blockers are disabled for the browser that you're using.
- 3. If you use a Video Speed Controller, please disable this browser extension before starting the course.
- 4. If leaving your computer for 30 minutes or more, please exit the course to ensure your most recent progress is recorded.

When you have completed the Title IX training, you will be able to move forward to enroll in classes.

HGSE Foundations Course Enrollment

Once you have completed the My.Harvard check-in process and the Title IX training (as described above), you may begin the course enrollment process. Residential part-time Ed.M. students admitted in 2022 are expected to complete all Foundations courses in order to graduate. Residential part-time Ed.M. students will take the Foundations courses during the summer and may take them in the sequence that is best suited to them.

HGSE recommends that residential part-time students take at least two Foundations courses in their first June and August Term at HGSE. For part-time students taking two Foundations courses in their first year, the Degree Programs Office recommends taking How People Learn (HPL101) in June-July and Equity & Opportunity (EQ011) in August of the first year, if feasible, and taking Leading Change (LCH101) and Evidence (EVI101) in August of the second year. How to enroll

Step 1: You can enroll in courses directly through My.Harvard.

Step 2: Follow these instructions to register in How People Learn.

How People Learn (HPL101)

Enrollment in How People Learn (HPL) is optional in the first year **(but highly encouraged)** for all incoming Ed.M. residential part-time students. Registration for HPL starts tomorrow, Tuesday, May 3 at 12:01 a.m. ET. And will close on Tuesday, June 21 at 11:59 p.m. ET. We highly encourage you to enroll as soon as possible and before the start of HPL (June 3).

Please note that even if you decide to take HPL in your second year, you MUST complete the 2021 summer My.Harvard Check-in process. Because My.Harvard check-in process is required for the Ed.M. students, and June 21 is the last day to complete the process, students who do not complete the My.Harvard check-in process by June 21 forfeit their admission to HGSE. Any future pursuit of the Ed.M. at HGSE would then require reapplying to the program.

If you opt to take HPL this year, you will have access after you register the introductory page of the course Canvas website. Please complete the availability survey linked from the HPL site as soon as you register. This will help us place you appropriately in small Teaching Fellow-led course sections.

You can access the Canvas course site by logging in to My. Harvard and navigating to "Course Search." Search for How People Learn and click on "Course Site."



Equity & Opportunity

As part of your Foundations experience in Equity & Opportunity, all residential Ed.M. students will take an August Term "Identity in Context" course. As <u>described elsewhere</u>, the Identity in Context courses immerse you in inquiry about one of six dimensions of social identity: Class, Dis/ability, Gender & Sexuality, Race & Ethnicity, Citizenship & Nationality, or Language. If you plan to take your Identity in Context module this year, we invite you to **indicate your preferences among these six topics**. Your preferences will be taken into account when placing you in August course sections. Note that we encourage you to prioritize topics that are relatively new to you—academically, experientially, or both.

To help you identify your topic preferences for Identity in Context, we encourage you to explore the information and resources available here: https://bit.ly/HGSE_EandO. This site includes guidance from the E&O faculty, reflections from past students, examples of course readings and guiding questions, and access to a self-assessment developed by HGSE faculty members to help you reflect on your growth edges.

<u>Please follow these instructions on how to use the "lottery event" feature in My.Harvard to submit your topic preferences.</u> You will be able to enter your preferences starting tomorrow, Tuesday, May 3. The deadline to submit your topic preferences is Friday, May 13 at 4:00 p.m. ET.

To indicate your preferences you will rank-order the available topics. Since some topics will be taught in either in-person or online formats, those options appear separately so you can take your preferred modality into account.
