You are receiving this email because you have not completed one or more Foundations courses required to complete your graduation requirements. You must complete your missing Foundations course(s) this August Term. Please see below for instructions for each course enrollment.

1. ***Equity & Opportunity: Identity in Context***

[Action Required: Must complete by Monday July 8th. If you are missing Equity and Opportunity, please follow these instructions]

As part of your Foundations experience in Equity & Opportunity, all residential Ed.M. students will take an August Term “Identity in Context” course. As [described elsewhere](#), the Identity in Context courses immerse you in inquiry about one of six dimensions of social identity: Class, Dis/ability, Gender & Sexuality, Race & Ethnicity, Citizenship & Nationality, or Language. With this email **you are invited to indicate your preferences among these six topics within My.Harvard**. Your preferences will be considered when placing you in the August course sections. Note that we encourage you to prioritize topics that are new to you—academically, experientially, or both.

To help you identify your topic preferences for Identity in Context, **we encourage you to explore the information and resources available on the** Equity & Opportunity **Foundations Canvas site:** https://bit.ly/HGSE_EandO. This site includes guidance from the E&O faculty, reflections from past students, examples of course readings and guiding questions, and access to a self-assessment developed by HGSE faculty members to help you reflect on your growth edges.

After you have submitted your topic preferences, the Office of the Registrar will officially enroll you in Equity & Opportunity. This means that **no further action** is required on your part. You will see your placement in my.Harvard by the end of the day on Monday, July 15th.

2. Leading Change and/or Evidence [if you are missing any of these two courses or both, please see below]

The Office of the Registrar will officially enroll you in all your missing August-Term Foundations courses (LCH101 and/or EVI101); **no further action** is required on your part. You will see your placements in my.Harvard by the end of the day on Monday, July 15th.

*****IMPORTANT *** Please note that enrollment and registration holds will be ignored for the Foundations course registration process. You have until Thursday, August 1st at 12:00 pm ET to clear any holds, or your Foundations course(s) will be dropped from your enrollment.**
