### **Fall Registration Deadline**

As a reminder, **today, Friday, September 1<sup>st</sup> at 3pm is HGSE registration deadline**. After this deadline, all courses will require instructor consent. Please visit our [Fall Registration 2023](#) page for detailed information of the course enrollment process and deadlines. **Please note that HGSE add/drop deadline for Fall full term and Fall 1 modules courses is Monday, September 18<sup>th</sup>; after this deadline, courses may no longer be added. (The add/drop deadline for HGSE Fall 2 module courses is Wednesday, October 25<sup>th</sup>.)**

### **Registration and Course Credit Policies**



### **Credit Limit**

**Full-time students** must register for a minimum of 12 credits and a maximum of 20 credits per semester (Fall full term, Fall 1 & Fall 2 modules). **Part-time students** must register for a minimum of 6 credits and a maximum of 10 credits per semester (Fall full term, Fall 1 & Fall 2 modules). Please note that credits taken towards your Program Core Experience (Ed.M. students) count towards the minimum and maximum credits per semester.

## Approved Class Permission – Take Action!

When your petition is approved, **do not forget to enroll in the course!** Please note that this only applies to “Open Enrollment” and “Instructor Permission” courses. For Lottery-based enrollment courses, if a petition is approved, you will be added to the waitlist, if any. Make sure the course is listed under your enrolled courses in my.harvard.
